High School Principal Chris Garard at the previous board meeting inquired if he could have the boards support to also include the "Latin Honors" in the graduation ceremony this year. The board was in favor of this addition to graduation honors.

Curriculum Director:

Erin Nuss, Curriculum Director, (report is attached to these minutes)

Curriculum Director Erin Nuss shared the recently-updated report card for the GCMS schools which can be found at www.illinoisreportcard.com. Results of the spring 2015 PARCC exam were reviewed and PARCC parent letters explained. The second semester social-emotional learning focus will be on internal bucket-filling: How MINDful is your bucket? A brief overview of mindfulness was provided as it will be explained to staff on January 4, 2016. A letter was sent home to all parents of GCMS High School juniors explaining the Board of Education's decision to continue funding the ACT. Voluntary ACT results were also dispersed to students. Mrs. Nuss described the variety of outside professional development that teachers and staffs have participated in thus far this year. An overview of the assessments run through the Curriculum Office this week was provided. Mrs. Nuss needed with an explanation of all the new technology purchased with Title I funds.

Middle School Principal Darnell expressed his appreciation for the Gibson City Courier Editor Patti Welander's for all she has done for the district. The last Gibson City Courier will be printed on December 30, 2015.

Superintendent's Report

Correspondence/Communications

Superintendent Galindo informed the board that the State of Illinois approved the corrective action response to state monitoring visit.

Superintendent Galindo presented the **2015 Tax Levy** for the GCMS School District to the board. The amount of the requested levy is \$6,931,340.00 this is an increase of 9.7%. All members were in agreement with the proposed 2015 Tax Levy. A motion to approve the GCMS 2015 Levy as presented. Motion made my board member Elder and seconded by board member Whitehouse. Motion carried by roll call vote with all members present voting yes.

Superintendent Galindo shared the prepared regular board meeting schedule for 2016. There were no objections to the meeting date schedule for 2016. **Motion to approval the regular board meeting schedule for 2016 as presented** Motion made my board member Zbinden and seconded by board member Leonard. Motion carried by roll call vote with all members present voting yes.

Superintendent Galindo stated that he received **mowing bid** information from Jeff Jackson. Mr. Jackson provided our mowing serves last year. Mr. Jackson has asked me to present a proposal for mowing services. The board did not want to pursue the extension of Mr. Jackson's contract at this time.

Superintendent Galindo reported that he received a FOIA request from the Paxton Record concerning the total cost for the district's part in the dispute to defend the assessed value on the One Earth Energy Plant. We will respond within the time required.

Bond discussion:

Mr. Kevin Heid with Stifel Nicolaus provided information related to Bond issue. At the last board meeting Mr. Heid addressed the board with concerns of property tax freeze that would limit the district ability to obtain bonds in the future that the district may need to operate. This is all in response to the state legation to enact a tax freeze. If this takes place the district would want to have an adequate base level. The board is concerned with the public's perception. Preparing for what could happen with state funding. No board member wanted to put any addition tax burden on the people. The board only wanted to issue a bond for \$1,000,000.00 and only sell \$500,000.00 at this time. Motions to consider approval of a resolution declaring the intention to issue **Working Cash Fund Bonds in an amount not to exceed \$1,000,000** for the purpose of increasing the District's Working Cash Fund and directing that notice of such intention are published in the manner provided by law. Motion made my board member Whitehouse and seconded by board member Leonard. Motion carried by roll call vote with all members present voting yes.

A motion to adjourn regular session was made by board member Leonard and seconded by board Elder at 8:14 pm. Motion carried by voice vote, with all members present voting yes.

Who will speak at graduation?

Senior nominated by the graduating class Honors recipients with final selection from a staff committee.

Farwell Address - THE speech given by A member of the graduating class.

Definition - Valedictory = Farwell address

Valedictorian - a student, typically having the highest academic achievements of the class, who delivers the valedictory at a graduation ceremony

Possibly add – Guest commencement speaker (Keynote Speaker) as a second speaker during the graduation ceremony.

Should we change the criteria for Honor Roll?

Some students do not take advanced classes because it might lower their GPA

Some students have asked to RETAKE courses in order to raise their GPA, not because it would increase their learning

Many of our high achieving students are not recognized

Classes are not recognized for the volume of high achieving students

Aligns with college recognition

Colleges do not require class rank

Ranks will not be included on transcripts unless specifically asked for from the University/College
